**1. Welcome and Apologies for Absence**

The Chairman of Kesgrave Town Council – Councillor Beecroft-Smith welcomed everybody to the Kesgrave Annual Town Meeting. He informed attendees of the Fire Evacuation procedures and emergency exits and advised attendees that this Meeting is for the Town, Local Residents and Organisations and is an opportunity for local Groups to submit Reports (both verbal and written), on their respective activity within the last year. Councillor Beecroft-Smith also advised that he would endeavour to answer any questions raised, but that if an immediate answer is not available, then he would arrange for the Town Council Office to deal with the matter as soon as practicable following this Meeting. The Council received apologies for absence from Town Councillors Hamilton and Patten. An apology for absence was also received from County Councillor Whiting. In addition, apologies were received from Mrs J Francis (Kesgrave Conservation Group), Mr M Rayment (Public Footpath Representative) and Ms S West (Patient Participation Group - PPG).

**2. Minutes of the last Kesgrave Annual Town Meeting held on the 3<sup>rd</sup> April 2017.**

**3. Matters Arising from the Minutes**

- Matters Arising Minute Number 9 – Resolutions – The Meeting noted that following on from last year's Annual Town Meeting that the Appeal regarding the proposal for 300 dwellings off of Bell Lane, Kesgrave and the associated highway alterations and changes is to go through a re-determined process. The Planning Inspectorate has advised that the process for this Appeal, (unless the appellant - Persimmon Homes Ltd, seeks to argue for this to be re-determined through written representations), is likely to be via a new Public Inquiry in late spring/early summer 2018. This provides an opportunity for previous representations to be reaffirmed – specifically in relation to updated information, material changes in circumstances and issues upon which the appeal was quashed. The LPA has confirmed that it is currently appraising what information it needs to compile and how it will formally present these details at the new Public Inquiry. (The re-determination process is as a result of some legal errors in law directly from the Secretary of State's Office).
- Matters Arising Minute Number 10 – Discussion and Open Forum – The Town Clerk reported that following on from last year's Annual Town Meeting that contact has been made with all HGV/LGV Training companies who use the Penzance Road route and the concerns of local residents were communicated. The Town Clerk has also been in contact with the Government's Driver and Vehicle Standards Agency (DVSA) to ask for it to reconsider using Penzance Road as an official test route. The said Government Office confirmed that this is not possible, as other roads and routes are not suitable for vehicles over 7.5 Tonnes. There are 13 routes in Ipswich, with two of these being in Kesgrave. The roads used are limited to Main Road/A1214, Bell Lane, Penzance Road and Beech Road.

It should be noted that the Town Clerk contacted three HGV/LGV testing companies. These were Essex Driver, Felixstowe Goldstar and Hamilton's. They all advised that they were only able to use the routes as instructed to them by national government. An email from the relevant national government department to the Town Council confirms this.

- With regard to Other Matters Raised, the Town Clerk advised an article was published within the Town Council's normal press releases asking the public for feedback with regard to the location of its notice boards, the Council's public seats and benches have been cleaned and the Town Council has liaised with the Town's PCSO and Suffolk Constabulary with regard to the speeding vehicles. Articles have also been issued in local publications asking local residents to cut back their private overgrown hedges and greenery, in particular if vehicular or pedestrian visibility splays are being blocked as a result.

#### **4. Chairman's Update**

Councillor Beecroft-Smith reiterated that it has been a busy, but exciting and inspirational year again at the Town Council and in Kesgrave.

Councillor Beecroft-Smith thanked Councillors' and community stakeholders in advance for their respective continued pro-active assistance with organising and proceeding with these future worthwhile projects and events for local people. (Full Report available upon request).

## **9. Shaping Kesgrave for the Future and Kesgrave Neighbourhood Plan Steering Group/Sub-Committee**

Mr J Ogden the Chairman of the Kesgrave Neighbourhood Plan Steering Group/Sub-Committee provided a verbal update to local residents' regarding this emerging Plan. Local people noted that the questionnaires are currently been analysed by a commissioned consultant; these services have been paid for by a grant. More consultation will follow with focus on young people under aged 25 years. Some engagement work with young people via the High School is also proposed. (Full Report available upon request).

## **10. Community and Recreation Committee**

Town Councillor A Comber, the Chairman of this Committee updated local residents about the success of the Millennium Jubilee Hall, including improvements to the access, the Town Council's Tuesday Evening Youth Club which is performing well following an independent audit and review, the new model Thursday Evening Youth Club (now under the management of Orwell), new play equipment at Oak Meadow via District Councillor Locality Budgets, the all-weather surface via SPARK funding, the renovated trim trail, low risk play equipment following professional risk assessment inspections, the Town Council offices assisting with the High School's Work Experience Programme, the arrangements for the WW1 Battle event and various community events as detailed in the Chairman of the Council's Report. Councillor Comber thanked the Town Council office' Staff' and Town Councillors for their assistance during the year. He also thanked District and County Councillors for assistance via their respective enabling community and locality budgets and also' SPARK for its funding assistance. ## **11. Play Area and Open Spaces Sub-Committee**

Town Councillor Comber, the Chairman of this Sub-Committee updated local residents' regarding plans to adopt Holly Gardens and Dobbs Drift play areas from the District Council. (Full Report available upon request).

## **12. Traffic and Pedestrian Matters**

County Councillor Lawson gave a brief verbal update and thanked various people for their assistance since his term of office. Mr J Lewis the Community Engineer who covers Kesgrave gave a full and detailed verbal update. Various discussions ensued with regard to pot holes in the Town. Mr Lewis responded to various questions and queries. Mr Lewis explained the Suffolk County

Council Highways restructure effective since September 2017 and he endeavoured to give some background information to the county wide approach, the difficult winter which has added to the issues with pot holes, twice as many reports of pot holes since last year, the fact that as a Community Engineer he is one of six Engineers for the whole of Suffolk; covering 180 parishes, where Mr Lewis covers 62 different wards. Mr Lewis explained the online reporting tool and the County's system for prioritising in line with safety and mitigation, the methods of repairing potholes, the economics, different approaches which the County are currently exploring, the fact that Highways England manage the A12 and A14 and highways of higher risk and where the speed limit is 70 miles per hour, various specific roads and junctions in the Town; including the junction at the Recycling Centre with regard to speed and safety, drainage and new soakaways in Bell Lane not being cleaned frequently enough to remove silt and leaves, the iron work on the road and its level at Bell Lane, white lines, budget issues and a request for a more precise structure plan. Mr Lewis and County Councillor Lawson agreed to investigate further some of the issues raised and report back to the Town Council in due course.

### **13. Resolutions**

No Resolutions were received in writing and no verbal Resolutions were made at the Meeting.

### **14. Discussion and Open Forum**

Members of the Public raised the following matters during the Meeting including; the Love Kesgrave Litter Picking event on Saturday, 28<sup>th</sup> April 2018 from 10am – 12 noon – meeting at the Town Council offices, a suggestion to invite a representative from the local Doctors Surgery to the next Meeting, planning and development queries, ~~Ms J Cody (local resident) agreed to looking into setting up a Community Land Trust in order to purchase the two ransom trips of land near Tesco, Ferguson Way;~~ Town Councillor A Athwall and Mr P Athwall agreed to join this Trust, Councillor McCallum asked for volunteers to help with the Kesgrave 5k Fun Run on Sunday 6<sup>th</sup> May during the morning to assist with registration and Town Councillor A Athwall and Mr P Athwall agreed to help and an update from District Councillor Mower was received about the Age UK "Big Chin Wag" event which is held on the third Friday of every month at the KWMCC (Kesgrave War Memorial Community Centre).
